## Property Tax Rebate Program

The Property Tax/Rent Rebate Program supports homeowners and renters across Pennsylvania. The State operates this program to provide a rebate ranging from \$380 to \$1,000 to eligible older adults and people with disabilities age 18 and older. This program is supported by funds from the Pennsylvania Lottery and gaming.

The Wissahickon School District understands that some of our taxpayers can benefit from tax relief. As such, the Wissahickon School District wants to also provide a Property Tax Rebate Program. The property tax and rent rebate program is based on the existing Pennsylvania Property Tax and Rent Rebate program. Wissahickon School District homeowners and renters must qualify for the state rebate program to qualify for the district rebate program. Wissahickon School District will approve a thirty percent (30.00%) rebate, up to \$195, as follows based on the amount approved by the state.

To Qualify for a rebate from the Wissahickon School District you must meet the following eligibility criteria:

### *Residency*

This program supports Pennsylvania homeowners and renters living within the Wissahickon School District boundaries who meet the following criteria.

### *Age Criteria*

- 65 and older
- Widows and widowers 50 and older
- People with disabilities 18 and older

### *Income Criteria*

- In addition to age requirements, to qualify for the Property Tax/Rent Rebate, your household income must be \$46,520 or less annually.
